False Trade Description and Mis-selling

Common Criminal Legal Traps in Business Operations

The Trade Descriptions Ordinance prohibits specified unfair trade practices deployed by traders against consumers, including false trade descriptions of services, misleading omissions, aggressive commercial practices, bait advertising, bait-and-switch and wrongly accepting payment. It also introduces a civil compliance-based mechanism to encourage compliance by traders and to stop identified non-compliant practices. With business operations interfacing more with criminal liabilities, this workshop aims at introducing those less noticed but common criminal offences that business need to be alerted to when conducting business operations, including false trade description, mis-selling, dishonest use of computers, infringement of copyright, cybercrimes and the rest.

Through case studies and legislation review, managers, business executives and SME owners may prepare properly to avoid such criminal legal traps and to safeguard their personal and enterprise interests.
