Legal knowledge is becoming more and more important to officers, professionals, managers and executives for enabling the proper discharge of their duties. With a view to strengthening the legal knowledge and skills of the working personnel, this series of seminars are tailored and designed for meeting the growing needs and demands in their daily routines.

This course equips participants involved in business dealings in or with Mainland China an introductory but yet comprehensive legal education in the essential commercial laws of both Hong Kong and Mainland China. The aim is to upgrade their competence in tackling commercial and corporation situations with legal implications and for avoiding pitfalls that may flow from the differences and discrepancies between the laws and the legal systems of Hong Kong and Mainland China. Those who attend this course will be able to acquire a greater understanding of the structure of both the Hong Kong and China legal systems, the interactions between them and a practical comparison of the business consequences. With these, the ways commercial disputes are handled under the laws of Hong Kong and Mainland China may be formulated.

Objective: Completion of the course should enable participants to:-

- Understand the essential laws regulating business transactions and corporation operations in Mainland China and Hong Kong
- Learn how to apply practical but proven approaches in assessing options available in handling such business transactions and operations
- Become familiar with legal differences and discrepancies between the business laws in Mainland China and Hong Kong
- Prevent and avoid pitfalls and problems in situations of involving Mainland China and Hong Kong business laws and disputes
- Deal with and handle business matters and disputes in their workplace

Format: Each of the 2 seminars is for one day (0930-1700).
